

I AM I FEEL THERAPY WEBSITE TERMS & CONDITIONS

Introduction

These terms and conditions apply between you, the User of this Website (including any sub-domains, unless expressly excluded by their own terms and conditions), and I am I feel Therapy, the owner and operator of this Website. Please read these terms and conditions carefully, as they affect your legal rights.
